APPOINTMENT PROCEDURES

I. APPOINTMENT OF FACULTY MEMBERS

Faculty appointments are made through the Kerala Public Service Commission recruitment procedures. The process includes following steps,

Step 1: Online application submission by the candidates with minimum prescribed qualifications

Step 2: Written examination with descriptive questions

Step 3: Short-listing of candidates for interview after fixing a cut off mark

Step 4: Interview for the short-listed candidates

Step 5: Final rank list after including weightages for publications, PG mark, etc.

Step 6: Issue of Advice Memo by the KPSC on the basis of reservation rotation chart

Step 7: Issue of Appointment Order by the Director of Collegiate Education, Kerala to those who are issued the advice memo

II. PROMOTION AND PLACEMENT OF FACULTY MEMBERS

The faculty placement and promotion are done through Career Advancement System (CAS) based on Performance Based Assessment System (PBAS). Each faculty member with certain minimum number of years in service prescribed for a particular placement/promotion has to prepare self-appraisal forms along with required forms and supporting documents to the IQAC. IQAC verifies the placement/promotion proposals and forwards to Screening Committee appointed for the purpose of placement/promotion. The screening of proposals for Associate Professor and higher levels are done at the Directorate of Collegiate Education directly. All lower-level placements are done within the college by forming Screening Committee separately for each subject by including external experts.

 - iv) KS & SSR Part II Rule 10 (a)(ii) is applicable.

- v) Candidates who claim equivalent qualification instead of qualification mentioned in the notification shall produce the relevant Government Order to prove the equivalency at the time of verification, then only such qualification shall be treated as equivalent to the prescribed qualification concerned.

Name of the candidate and the date of photograph taken should be printed at the bottom portion. The photograph once uploaded meeting all requirements shall be valid for 10 years from the date of uploading. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates shall take a printout of the application by clicking the link Registration Card in their profile. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application, candidates must ensure correctness of the information in their profile. They must quote the User-ID for further communication with the Commission. Application submitted is provisional and cannot be deleted or altered after submission. The application will be summarily rejected if noncompliance with the notification is found in due course of processing. Documents to prove qualification, age, community etc have to be produced as and when called for.




